### SUPERINTENDENT'S MESSAGE

#### **Dear MCS Community Members,**

I would like to begin this year's budget letter with a brief update on the progress made on the capital project that our community graciously approved in May 2022. The following renovations have been completed:

- · Elementary classroom floors, ceilings, lighting, bathrooms
- · 1988 wing flooring and vestibule doors

These renovations are in progress:

- Library
- · Upgrades to announcement, clock and alarm systems

In addition, the following renovations will also be completed by the end of this summer:

- · Soccer field resurfacing
- · Nurse's Office
- · Parking behind athletic field
- · Parking lot resurfacing
- · Some roofing replacement
- · Additional flooring, door and window replacement

Please feel free to stop by to check out the improvements. Once all portions of the project are completed, we will host an Open House and provide tours of the updated spaces. We look forward to hosting you.

As always, this year's budget process was guided by the goals set for the District by the Board of Education. You can review our Board goals on our website at <a href="https://www.madisoncentralny.org/board-of-education/index">https://www.madisoncentralny.org/board-of-education/index</a>. I would like to highlight one major success related to our District goals. In 2018, as part of New York State's new accountability system, MCS was placed on the original "Comprehensive Support and Improvement" list by the NY State Education Department because of inadequate student performance on the NY State 3-8 ELA and math assessments. Subsequently, our faculty, staff and administration has been focused on improving student achievement. I am proud to share that our student performance on the 3-8 assessments has improved significantly and MCS is no longer designated as a "Comprehensive Support and Improvement" school. Please join me in celebrating this achievement.

On May 21st, the first item on the ballot for your consideration will be the proposed 2024-25 budget. Highlights of the budget include:

- Total adopted budget of \$12,947,322, a 4.32% spending increase over 2023-24
- Total State Aid of an increase of \$57,487, only a 0.75% increase over last year
- A proposed tax levy increase of 3.35%
- Maintenance of all student academic and extracurricular programs

Our Budget Hearing will take place in our Auditorium on May 7, 2024 at 6:00 p.m. We will also hold a budget presentation at the Knoxboro Town Office Building on May 16, 2024 at 6:00 p.m. We encourage you to attend one of these informational sessions. If you are unable to attend one of the presentations, please feel free to reach out to me with any questions you may have. The annual budget vote will occur at Madison Central School on May 21, 2024 from noon until 8:00 p.m.

On behalf of the Board of Education, our students, faculty and staff, thank you for your continued support for MCS as we strive to move our district forward. Go Blue Devils!

## **Voter Information**

Tuesday, May 21st - Noon to 8 PM - Madison Central School

## Voter Requirements

- Must be a citizen of the United States
- · Must be at least 18 years of age
- Must be a resident of the school district at least 30 days prior to the meeting which he/she offers to vote.
- Must not be prohibited from voting under the provisions of Section 5-106 of the Election Law (having been convicted of a felony or adjudged mentally incompetent)
- Must present proof of residence with a picture, such as a driver's license or non-driver identification. (upon request)

## **Absentee Ballot Procedure**

- Qualified voters who wish to vote using an absentee ballot can request an application from the District Clerk at Madison Central School.
- Completed applications for absentee ballots must be received by the District Clerk no later than 5 p.m. on May 15th, 2024 in order to receive an absentee ballot by mail.
- Application requests after May 15th must be made in person at the District Office, located in Madison Central School at 7303 State Route 20, Madison, NY, to pick up an absentee ballot. Completed absentee ballots must be received by the District Clerk by 5 p.m. on May 21, 2024. Completed ballots received after this time cannot be accepted.

## 3RD MARKING PERIOD HONORS ANNOUNCED

Madison, NY - Madison Central School is pleased to announce that 74 students in grades 6-12 have earned academic honors for the third marking period of the 2023-24 academic year. 28 students received high honor roll status for the quarter after achieving an overall average of 94 or higher, while an additional 46 students secured honor roll commendations for an average between 88.0 and 93.9.

The Madison Central School District is pleased to announce that ten members of the Class of 2024 have been inducted to the Madison-Oneida BOCES chapter of the National Technical Honor Society. The honor was made official in a ceremony held on Wednesday, March 27th at the Vernon Verona Sherrill High School Auditorium.

NTHS is an honor society recognizing exceptional student achievement in career and technical education. To be eligible for membership, students must maintain a minimum 3.0 grade point average in their CTE program and their high school. Accepted members must also participate in extracurricular activities at BOCES and/or their home school, demonstrate exceptional character, and carry the endorsement of their CTE teacher. They must also exemplify and uphold the NTHS values, consisting of knowledge, skill, honesty, service, responsibility, scholarship, citizenship, and leadership. NTHS membership is a distinction achieved by less than five percent of CTE students nationwide.

Madison's representatives were part of a historic induction class for the MOBOCES Chapter. The Chapter inducted a record 146 new members, and for the first time, every senior-level Career and Technical Education program had an inductee recognized in the same ceremony.

The occasion was also special for one member of the Madison Central School community. Richard Engelbrecht, a 1963 graduate of Madison, was honored by the chapter with an honorary lifetime membership. Engelbrecht is the current MOBOCES Board of Education President and has represented Madison on the board for over 50 years. He started his time on the MOBOCES Board in 1972 and was on the Madison Central School District Board of Education prior to his current post.

### Ninth Graders Go On Immersive History Field Trip



Mrs. Collins recently took her ninth grade English students on an exciting local history field trip. The group toured some fascinating local sites that have shaped the course of American history.

The day began at the Oneida Community Mansion House for a tour of the premises. The mansion housed one of the nation's most interesting and peculiar religious utopian societies beginning in 1848, and it lasted just over 30 years. At its height, the community had over 300 members. The community had social norms that were very different from the norms of the time, and grew to have a very complex bureaucracy overseeing its activities. It had a growing industrial influence over the years, making products such as hunting traps and silverware. When the community dissolved, the businesses carried on under one of the nation's first joint-stock companies. You know it today as Oneida LTD.

After the mansion, the group enjoyed lunch at the Peterboro General Store. They went on to tour the Gerrit Smith Estate and the Abolition Hall of Fame and Museum. Smith was born in Utica before it was incorporated as a city, was the first-ever valedictorian at Hamilton College, and went on to become a major political figure and abolitionist. His home was a well-known stop on the Underground Railroad, and students got to see a barn that was regularly used to house people as part of that operation. At the Abolition Hall of Fame and Museum, the students learned more about abolitionists, how they supported slaves in their pursuit of freedom, and how Peterboro became the unofficial capital of the Abolition movement in America.

The trip tied into the class's local history research project that they have been working on over the past few months.

## Winterton Receives REV Theater Co. Echoes Award



The Madison Central School District is pleased to announce that sixth grader Kenleigh Winterton has been selected as a featured writer in the 2024 REV Theatre Company Echoes program.

Winterton was recognized for her submission, a short story entitled "The Winter I Felt Alone."

The Echoes program is one of the largest writing competitions for Middle School students in the United States. Students across New York State submit approximately 4,000 pieces to the company for consideration each year. From those 4,000 pieces, a few dozen are selected to be incorporated into the script of an original 50 minute production.

The program starts in the Fall with a classroom workshop taught by one of the company's actors. After that presentation, students have the option to work on a submission independently. Winterton completed her story in October and felt the decision to put an entry together was an easy one.

"Writing is my favorite," Winterton said. "I just do it for fun."

The story took approximately one day to write. Once the work is submitted, it becomes part of a lengthy and thorough review process among thousands of talented writers.

Months of review and preparation build the anticipation for an exciting reveal when the event goes on tour. On March 25th, that tour came to Madison and Winterton learned she was one of the winners in front of her peers. She was recognized by the company's actors on stage and received a plaque and certificate.

For teacher Kelly Diehl, the honor is a reflection of the example Kenleigh sets in class each day.

"She's phenomenal at everything she does," Diehl said. "She's a great role model for the other students and an inspiration for her classmates."

In recent years, getting recognized by REV has been somewhat of a family affair for the Wintertons. Kenleigh's older sister, Kendra, was the recipient of the Best Overall Submission award for the 2020-21 academic year as an eighth grader. Kendra is now a junior at MCS.

### **Eight Picked to CCL Hoops All-Stars**

MADISON, NY - The Madison Central School District is pleased to announce that eight Blue Devil student-athletes have been selected to the 2023-24 Central Counties League Basketball All-Star Teams. The honors were released by the league following surveys of the league's coaches.

The Madison girls' basketball program received five selections on this year's list, while the boys' basketball team notched three selections. Both squads advanced to the Section III Quarterfinals this season. The girls' program won the Central Counties League championship and finished with a final overall record of 13-9. The boys' program achieved a final overall record of 12-10 and landed in third place in the Central Counties League.

Headlining Madison's honorees was senior Camryn Parmon, who was voted the CCL's Most Valuable Player in girls' basketball. Parmon averaged 10.1 points per game and is seventh among all Section III players through the end of Sectional Tournament play with 242 rebounds. She logged ten double-double performances this season, and scored in double figures fourteen times. Through March 5th, her 71 blocked shots ranked third among all Section III performers. She also received first team honors.

Joining Parmon on the girls' first team was senior classmate Mackenzie Cotter. Cotter averaged 7 points per game to rank sixth in the league, and was also second among CCL performers with 56 steals. She ranked fourth in the league in field goal percentage.

The boys' squad was led by first team selection Jacob Burns. The dynamic junior guard averaged 15 points per game to set the pace for the Blue Devils and stand third in the Central Counties League in scoring average, and his 90 total assists led the league this year.

The Blue Devil programs secured a total of four second team selections with two from each squad.

For the Madison girls, seniors McKenzie LaMunion and Lauren Zehr were named to the second team. LaMunion averaged 5.3 points per game and shot over 30 percent from the field. Her 136 rebounds ranked fifth in the CCL. Zehr's 27 assists were good for third in the CCL, and she was fifth in the league in steals. She demonstrated tremendous versatility with 4.7 points per game and 87 total rebounds.

For the MCS boys, second team honors went to the frontcourt tandem of senior Malloy Brouillette and sophomore Justin LaMunion. Brouillette logged five double-doubles en route to an average of 8.9 points per game and 177 rebounds. LaMunion averaged 9.7 points per game and hauled in 137 rebounds. He finished the season with 39 blocked shots.

Finally, senior Cameryn Stanfield was picked as an honorable mention all-star in girls' basketball. Stanfield was a terrific rebounding guard with 73 rebounds and she produced 54 steals to rank fourth in the Central Counties League. Stanfield averaged 5.0 points per game and came up huge in the postseason with a career-high 16 points in the team's first round game against Stockbridge Valley.



#### MCS Scholar-Athletes Recognized

The Madison Central School District is pleased to announce that thirteen winter varsity student-athletes and one winter sports team have been recognized by the New York State Public High School Athletic Association for their academic achievements as part of the Association's Winter Scholar-Athlete awards.

The awards recognize high levels of academic commitment while competing in a varsity-level sport.

To achieve team honors, at least 75 percent of a team's roster must achieve an overall average of 90 or above during the season. The girls' varsity basketball team was able to achieve this. Award qualifiers from the team were Janet Coleman, Mackenzie Cotter, McKenzie LaMunion, Catherine McBride, Camryn Parmon and Lauren Zehr.

An additional seven Madison student-athletes were recognized with individual honors. Three student athletes from the Madison Central School District had a successful season with the Morrisville-Eaton boys' varsity wrestling team. The season concluded for the Blue Devil trio after the Section III Division II Championship held on Saturday, February 10th at SRC Arena in Syracuse.

Senior Kyle Peavey polished off an accomplished interscholastic career with a sixth place finish on the Section III Division II podium at 145 pounds. In prior weeks, he was third at the Section III Class D tournament, and also placed second in the Center State Conference tournament in his weight class. He finished his senior season with a record of 35 wins and 13 losses. 21 of his victories came by way of pinfall.

During his career, he placed on four consecutive Section III Class D podiums, and also landed a medal spot in the last two Section III Division II Championships. He is also a three time Center State Conference runner-up. He will finish with 112 career wins.

Alongside Peavey, senior Shawn Murray also represented Madison and Morrisville-Eaton at the Section III Division II Championships. Murray went 1-2 at the tournament in the 138 lb. classification. He was the Section III Class D runner-up at 138 lbs., and has landed in the top 3 of that tournament on three occasions, including his 2020 Class D title at 106 lbs. Murray wraps up his career with 71 wins, with 50 coming by way of pinfall.

The two seniors were joined on this year's varsity squad by ninth grader Davin Peck. He collected 15 wins this season and secured fifth at the Center State Conference Tournament. Through two seasons on the varsity squad, Peck has won 27 matches and has won 12 by pinfall.

## Finding Her Voice

Like many students her age, Olivia Crane didn't consider herself to be big on public speaking growing up. With one courageous leap into the arena of competition and two years of experience to draw upon, it's safe to say that reputation has changed. On Saturday, April 27th, Crane advanced in the Optimist International Oratorical Contest by taking first place at the New York/New England District Championships held in New Hartford.

Crane prevailed against nine other high school students from around the region, and ensures her a spot in the regional round at the Optimist International Oratorical Contest World Championship weekend to be held from July 17th to 19th in St. Louis, Missouri. The long-running competition is rich in history as it approaches its 100th anniversary in a few years' time.



Crane will be the first student to represent the Madison Optimist Club at that event. Her win also secured \$2,500 in scholarship money, which she will use to pursue studies in the Health Science program at Mohawk Valley Community College in the Fall. With her education, she hopes to become a Registered Nurse.

The win is the latest triumph on a fulfilling personal journey that began last year. In 2023, she advanced out of the Madison contest as the runner-up, refined her speech to win the Zone competition, and ended up third in the District Championship.

The journey began in early February 2024 as Madison students presented classroom speeches. This year's theme, "How to Change the World with Optimism", brought out the best in several students who applied their own personal experiences to create dynamic and interesting speeches that are 4 to 5 minutes in length.

With a heartfelt reflection on how to spread a positive mindset and a year's experience in tow, Crane was eager to rise above the challenge and take the next two steps on the District podium. She won the school-level competition among a dozen of her peers on February 29th and won the Zone contest for a second straight year before her district victory.

For Crane, a steadfast commitment to live her message has been the key to her success.

"Although getting up in front of a crowd is scary, I remember to tell myself that someone else is going to walk out feeling inspired and motivated," Crane said. "To me, that is beyond rewarding. That is why I'm doing this. My speech was never supposed to be about me, it's about the listener. It's about how life is such a beautiful gift, and how there is no better way to live it than to be kind."

As for the next step, she's excited to put her best effort on a global stage while seeing what her competition from around the world has to offer.

"It feels so daunting, yet unreal," Crane said. "I'm really looking forward to hearing the other speeches, and seeing the talent that brought them to Missouri, just as it brought me. This is such a huge achievement for me, and I am so unbelievably proud to represent Madison Central."

## Will Cotter '76 Starts Cooking Up His Next Chapter



Stop us if you've heard this story before, but Will Cotter is retiring. You may have heard that story eight years ago, when the longtime executive chef at the White Eagle Conference Center hung up his apron after 30 years, but he had another story to write yet on his culinary odyssey.

That story brought him back to where his career in the Culinary Arts began: Madison Central School, where he has served as cook manager for the last eight years. When he was in school, Cotter worked washing dishes. He began his 48 year professional culinary career working just down the road at the Colgate Inn. He ascended through the ranks at the Inn before heading southward. His goal? Make his way from state to state and learn what he could at each place he worked heading down the coast.

In a way, he got there, but the route was far more drastic than gradual.

For about eight years, Cotter settled in Southwestern Pennsylvania where he worked in a variety of settings including country clubs. He had the privilege of working directly under a certified master chef who was also an experimental chef with the Heinz Corporation. He also worked in a four-star restaurant owned by the highly influential Mellon Family. He became certified with the American Culinary Association, took some classes at the Culinary Institute of America, and headed south to Florida, where he continued to work on the country club circuit in places like Innisbrook, which is currently a host course on the PGA Tour.

Eventually, he came home to Oriskany Falls to live the dream of opening his own restaurant, called the Cassety House. That led into his long career at the White Eagle Conference Center, and his present role we know today. As Cafeteria Manager, Cotter has updated the logistics of his cafeteria lines to help traffic flow faster. He also updated the menus to include a wider variety of foods like paninis and different types of pizza and local favorites like chicken riggies.

For Will, the food has been a focus, but working with the students has been at the center of the plate.

"I love taking care of the kids," Cotter said. "I have a lot of fun with the kids, and I love making them happy."

In June, Will will have a second MCS graduation of sorts - as an employee and parent - alongside his daughter Mackenzie, who is the Class of 2024 Valedictorian. He will remain on through the summer months to oversee the Summer Nutrition Program, before handing over the chef's hat to his successor.

While he is headed off to a well-deserved retirement from his culinary career, don't assume Will is slowing down. He has farmland, and also enjoys hunting and fishing in his spare time. Coupled with family time, a busy retirement will be on the menu.
