The addition of these technology devices also will contribute to the reduction of learning gaps at Madison by allowing students to collaborate with each other as well as the teacher in a wide variety of methods, access information and resources, and enhance educational methods in relation to learning styles.

All students including students with disabilities and English language learners will utilize software such as the built-in whiteboard software on the interactive tv's and be able to utilize the ipads in art classes. The interactive tv's allows students and teachers to utilize google drive, classroom and other approved cloud-based tools to collaborate
